To receive this rebate, you must:

1. Purchase a new, eligible GE dishwasher to replace a dishwasher included in the 2012 GE Dishwasher Recall.

To determine if your dishwasher is included in the recall, visit geappliances.com/recall. Or you may call the Recall Hotline toll-free at 1-866-918-8760 Monday through Friday (8:00 a.m. – 5:00 p.m. Eastern Time).

When prompted, select the recall rebate option instead of the repair option. **You may not have both.**

2. Complete this form, providing your name, address and phone number.
3. Attach the sales receipt from your new dishwasher to this form. Receipts must show **date of purchase on or after the recall announcement date** and include your retailer's name, your name, address and new dishwasher model number. **New dishwashers must be purchased from an authorized GE retail dealer or participating Authorized Builder Distributor (ABD).** This rebate **DOES NOT** apply to purchases of used or as-is products.
4. **Remove the model number/serial number label from your recalled dishwasher, and return it with this rebate form.** Attach it to this form as indicated below. If the installer of the new dishwasher will not be hauling the old model away, be sure to properly discard it; it should not be re-used.

5. Mail this cash rebate form, the model/serial number label from your OLD dishwasher, and your new dishwasher sales receipt to:

- Your rebate check will be mailed to you in six to eight weeks. The check is valid up to 90 calendar days after issuance.
- The rebate can be used in conjunction with any other retail sales promotion.

Any GE Brand 24" built in Tall Tub Plastic or Hybrid Stainless interior models*

New GE or GE Profile dishwasher models eligible for \$100 rebate include:

Any GE Brand, GE Profile, GE Café, or GE Monogram 24" built-in stainless tub models*

* Does not include any Hotpoint Brand models or GE Brand in standard tub, 18" built-in, or under-sink models.
